1. I will abide by the rules & regulation of the school in all matters.
2. I am aware of the fact that the school is governs by AWES, Delhi and affiliated by CBSE. I will abide by rules & regulations issued by AWES & CBSE.
3. My ward will attend school regularly and will ensure minimum 75% attendance in academic year.
4. I am aware of School's Code of Conduct & Discipline stated in Chapter 13 'Discipline – Students'. A copy of which is with my ward. I give the assurance that my ward will abide by it in letter and spirit.
5. I shall ensure that my ward will conduct himself in and outside the school satisfactorily.
6. I shall visit the school authorities intermittently and remain in touch with authorities of the school to enquire and verify discipline and academic performance of my son/ward every month.

- (j) Crossing school boundary wall.
- (k) Getting items from shops across the boundary wall.
- (l) Damage to school and hostel property.
- (m) Sex related offences.
- (n) Any form of Gambling.
- (o) Rude and disorderly behaviour. Any other prohibited activities which violate the environment of school.

11. If my ward found indulging in above mentioned practices will liable to strict disciplinary action.
